### **2014 NADO Innovation Award:**

The National Association of Development Organizations recently recognized MRPC and its partners for the Fort Leonard Wood Joint Land Use Study. MRPC Chairman T.R. Dudley and Executive Director Bonnie Prigge presented the 2014 NADO Innovation Award to Waynesville Mayor Hardman on behalf of the City of Waynesville, who partnered with MRPC on the project. Pulaski County and St. Robert were not present to receive their awards.

## **Idea Exchange with Federal Legislators Staff**

Mr. Ray Bozarth for Sen. Roy Blunt; Ms. Tammy Corrigan for Rep. Jason Smith and Mr. Matt Williams for Sen. Claire McCaskill attended MRPC's board meeting.

Each representative for the legislators updated the board on legislative activity. The following is what they conveyed to the board:

Mr. Bozarth updated the board on Economic Development Bill; the senator would like to see an increase in manufacturing and technology in the private and public sectors to create jobs. Sen. Blunt supports BRO transportation funds and will continue to fight for them. He is working on expanding access to community health centers for mental health issues. He also supports the Clay Hunt Suicide Prevention Act for American veterans, which will provide more resources for veterans; and incentives for physiatrists.

Mr. Matt Williams informed the board that Sen. McCaskill's first priority is the Keystone pipeline. The House is going take up the issue on Jan. 9. He said Sen. McCaskill has concerns in regards to the new EPA regulations being implemented; she would like the timeframe to be extended to 2030. She is going to travel to Cuba next month to discuss opening up agriculture trade with Cuba.

Tammy Corrigan with Rep. Jason Smith's office informed that he is reviewing the Affordable Care Act and supports the Keystone Pipeline.

The group fielded questions from board members.

Darrell Skiles made a motion to approve the 2015 Federal Priorities as presented, Ray Schwartze seconded the motion. The motion passed.

Ms. Prigge updated the board on the EDA regulations that are in the process of being updated and sent. Staff believes the regulations are going to be better, what the board asked for. Staff is hopeful that control will be given back to the local board.

Ms. Prigge announced that docudrama/safety day training will be held at MRPC on Jan. 28.

Ms. Prigge reported DRA Meramec Workforce readiness grant has been approved for Phelps, Crawford, Washington and Dent counties. A kick-off meeting is planned soon.

The Missouri Department of Economic Development is still accepting projects to be included in the state's National Disaster Resiliency application.

MoDOT posted a rule in regards to tourism signs. One criteria for a given sign would require one million tourists, which would eliminate the opportunity for signage in rural areas.
