CDBG Planning Grant Final Report—Tammy Snodgrass

Approximately two years ago, the Missouri Department of Economic Development awarded all Regional Planning Commissions in the state a disaster planning grant, whereby the RPC could use its discretion and develop a scope of work specific to its area and needs.

MRPC staff decided on several projects:

- 1. Survey, Mapping and Report on Priority Bridges and Low Water Crossings
- 2. Collection and Compilation of Critical Facility Data
- 3. Storm Siren Inventory
- 4. Completed a community resiliency after disaster plan to be included as part of the CEDS

Bridge Survey

The bridge survey was an opportunity to work with local governments on bridges and low water crossings prone to flooding and counties were asked to prioritize their top three flood-prone bridges and low water crossings. Staff gathered data on each: year built, structure typed, tributary/stream, flooding frequency, repair and maintenance costs, latitude and longitude and elevation.

Information gathered provides data for future planning efforts, information needed to demonstrate need in the development of grant applications as well as critical data on the bridge itself. Assists the counties in prioritization of projects.

Critical Facility Data

Hazard mitigation planning requires detailed information on infrastructure and critical facilities. Staff used experience from working on hazard mitigation plans indicated that the datasets being used could be expanded and updated to provide better baseline data for planning purposes. Staff collected information on critical facilities in the region on emergency facilities, fire departments, medical facilities, law enforcement facilities and schools. The information in the database includes facility name, address, contact person, telephone number, census tract, longitude and latitude, facility classification, year built, square footage, back-up power, kitchen facilities, number of stories, number of trucks, replacement cost, shelter capacity, design level, building type, height of first floor and building type.

This dataset is not restricted to hazard mitigation planning. Information can be used for a variety of planning purposes such as: local emergency operations plans, comprehensive plans, strategic plans and capital improvement plans.

Storm Siren Survey

Another RPC conducted a storm siren inventory and staff thought that would be a useful project as well. Staff did a survey to get baseline data on the condition and coverage in the region for storm sirens. Information collected included: location and approximate range of existing sirens, number of sirens, type of sirens, needs for upgrades or additional coverage, backup system, existing infrastructure availability to add sirens, activation protocols, other warning systems available in the area and interest in participating in a joint purchase program.

Staff compiled the data and developed reports for each participating community and county. Reports included: demographic data for the jurisdiction including population and population density, data on warning systems available in that county and community, maps of approximate location of sirens and estimated coverage area and warning system need and interest in upgrading and/or adding sirens.

Disaster and Economic Recovery and Resiliency Strategy

This document provides guidance on how to prepare and plan to quickly recover from a disaster and includes: background on hazard mitigation, county hazard mitigation plan goals and objectives, information for business continuity management, disaster assessment guidance, recovery action planning and resources. This information is now part of MRPC's comprehensive Economic Development Strategy.

Hazard Mitigation Planning

Hazard Mitigation Planning is sustained actions that reduce or eliminate long-term risk to people and property from natural hazards and their effects.

Categories of Mitigation:

Prevention Property Protection Natural Resource Protection Emergency Services

Structural Projects

Public Information

The purpose of the hazard mitigation plans is to help counties, communities and schools become less vulnerable to natural disasters-to save lives and protect property.

It provides a blueprint for actions jurisdictions can take to implement hazard mitigation projects and programs. Also establishes benchmarks for progress and approved hazard mitigation plans are required in order to be eligible for hazard mitigation grant funds.

An additional piece of the project was to review hazard mitigation plans for the region and follow up with counties on the progress being made to implement their hazard mitigation grant funds to build tornado safe rooms, replace low water crossings with bridges, elevate roads, etc.

Ms. Snodgrass provided packets of all reports for each county.

External Relations Committee

Darrell Skiles reported on External Relations Committee activities as follows:

James Morgan reported on Planning Committee activities as follows:

• Home Rehabilitation in the Region

Maria Bancroft updated the committee on home rehabilitation in the region for the past several years, using various funding sources. Last year there were 17 homes rehabbed and, this year, there will be 19 homes renovated.

Mobility Manager

Lyle Thomas updated the committee on the Mobility Manager project.

• MoDOT Work Plan

Lyle Thomas presented the draft work plan for MRPC for FY 2014-2015.

Marvin Wright reported on Housing Advisory Board activities as follows:

PHA Financials

Staff presented a statement of revenues and expenditures for the month ending April 30, 2014.

Goals

Staff has set a goal of 756 units and is currently at 612 units.

Transportation Advisory Committee

Bonnie Prigge presented the report for John Casey, MRPC's transportation board member.

MoDOT has asked us to provide them with MRPC's top 15 highways/bridge priorities and 15 other moded priorities. Because highway/bridge projects were prioritized separately, those projects are known. Bonnie shared her methodology, for selecting the 15 other modes projects, based on the TAC's fund allocation

information. This resulted in three projects form aviation, six from bike/ped., two from transit, two from rail and two from non-modes making up 15 projects

Prioritized Highway Needs (1-15)

- 1. Phelps, Maries, Osage Counties-US 63 from US Hwy 50 in Osage County to the Phelps/Texas County line. Corridor improvements including widening to 4-lane. Shoulders and horizontal alignment improvements as well.
- 2. Gasconade County-From 28 junction to north city limits on Hwy 19 near school. Add third lane on Hwy 19 by high school. From Hwy 28/19 junction to north city limits sign.
- 3. Gasconade and Osage County-US Hwy 50 from about one mile west of Linn to the Gasconade/Franklin county line. Corridor improvements including widening to 4-lane. Shoulders and horizontal alignment improvements as well.
- 4. Crawford County-Bridge No. S0364 over Little Bourbeuse River. Load posted one lane bridge.
- 5. All Counties-Annually set aside funds for safety improvements on numbered and lettered routes, i.e. Correcting sight distance issues, intersection alignments and curve geometrics, adding shoulders, rumble strips and signage.)
- 6. All Counties-Annually set aside funds for award at the district level for bridge replacement on lettered routes
- 7. All Counties-Annually set aside funds for resurfacing of numbered and lettered routes and improving drainage where needed.
- 8. Phelps County-I-44 to University Drive/overpass at I-44 in Rolla. Roadway needs (additional lanes)/traffic control need (congestion concern).
- 9. Dent County-Bridge No. R0808 over Crooked Creek. Bridge need (flooding concern)/replace culvert with bridge.
- 10. Phelps County-MO72 from 44 to 63 extension. Extend Route 72 to I-44 at/near proposed 5th interchange.
- 11. Washington County-Crawford County line to St. Francois County line. Roadway need (passing lanes) continued improvement.
- 12. Washington County-Route 185 Bridge over FoucheARenault. Load posted, one-lane bridge.
- 13. Osage County-Entire route through county-functional/safety needs. Safety improvements to Rte. 133 across Osage County and add shoulders.
- 14. Osage County-Hwy 63 intersection with MO 133. Safety improvements at intersection.
- 15. Maries County-Intersection of US 63 and 42 in Vienna. Traffic flow issues, need to make improvements to the intersection.

15 Other Moded Priorities:

- 1. All Counties-Annually set aside funds for airport infrastructure construction, improvements and expansion (i.e. runway, apron and taxiway construction/expansion/repair, fuel storage/dispensing equipment, construction/upgrade). *Aviation*
- 2. All Counties-Annually set aside funds for facility construction, improvements and expansion (i.e. hanger expansion/construction, general aviation and passenger. *Aviation*
- 3. Rolla National Airport- Need to lengthen runway and/or fly zone. Rolla National Airport. Aviation
- 4. All Counties-Annually set aside funds for sidewalk repair, connectivity and expansion of facilities including pedestrian crossings, SRTS type projects and co-use trails and bike lanes. *Bike/Ped*.
- 5. All Counties-Annually set aside funds for upgrading pedestrian facilities to ADA compliance. *Bike/Ped*.
- 6. Region-Devote a percentage of annual funding to systematically adding needed shoulders. *Bike/Ped.*
- 7. Potosi City Park-Trail construction and renovation in city park, along Brenton Creek and around schools. *Bike/Ped*.
- 8. Potosi-Continued sidewalk construction and renovation in City of Potosi, especially SRTS & Public Housing Areas. *Bike/Ped*.
- 9. Osage, Gasconade, Maries Counties-Convert inactive Rock Island Railway into hiking trail. *Bike/Ped.*
- 10. All Counties-Establish Amtrak rail service from St. Louis to Springfield along the Burlington Northern rail paralleling I-44, making stops in Crawford, Phelps and Pulaski counties. *Rai*
- 11. All Counties-Annual funds set aside for rail infrastructure improvements (i.e. universal crossover installation, intermodal hubs, sidings, etc.) *Rail*

- 12. District Wide-Increased rural public transportation services provided from averaging 2 days per week to 5 days per week (i.e. OATS, SMTS). *Transit*
- 13. State Wide-Increase Park & Ride programs using smaller buses running more frequently. *Transit*
- 14. Regional-Matching grant program for cities and counties covering all modes for local projects. *Non-Mode*
- 15. Regional-Planning funds for Multi-Modal projects. *Non-Mode*

Ray Schwartze made a motion to approve the prioritization list as presented and presented to MoDOT; seconded by Steve Vogt. The motion carried.

Staff will present prioritization list at the May 28 workshop.
