Presentation: Issues Facing Senior Citizens-Don Brackhahn

Mr. Brackhahn, at large commissioner for senior citizens discussed the challenges and issues facing senior citizens in the Meramec Region. Currently, 11 percent of U.S. population is over 65 and that number is expected to be 22 percent in 30 years. Future planning needs to anticipate a large portion of the population being elderly. He discussed with the board the top concerns seniors have: health issues, sufficient income to live on and transportation options in rural communities.

Matt Williams & Kristen Wright, Senator Claire McCaskill

Mr. Williams introduced Ms. Wright to the board as he is leaving for other employment and Ms. Wright will be assuming his duties. They updated the board on the latest issues and news from Senator McCaskill. The Senator has just finished a tour of the state discussing issues that senior citizens have. They have finished up the latest round of veterans surveys. Overall surveys indicated that veteran hospitals are doing well.

External Relations Committee

Darrell Skiles reported on External Relations Committee activities as follows:

- Annual Dinner will be held at the YMCA of the Ozarks in Washington County on October 29, the ticket price will remain the same and so will the schedule. Award nomination has been extended to August 3 at close of business.

■ Lyle Thomas provided a brief overview of the Hazard Mitigation Plan update process and timeline for completion of the two plans. Staff shared new demographics for the 252 counties that make up DRA and discussed how the Meramec counties compare to other in the Delta region.

Transportation Advisory Committee

John Casey reported on Transportation activities as follows:

Preston Kramer, MoDOT area engineer, reviewed the new personal protective equipment guidelines for anyone working on MoDOT right-of-way. On June 23, MoDOT LPA will have training for LPA recertification at MRPC. Local governments with federal grants through MoDOT, including BRO and TAP, will need to be certified.

Connie Willman updated the committee on progress of the mobility management system.

Staff updated the committee on legislation. By 2017 the state will not be able to match federal funding for projects. T.R. Dudley shared that Rep. Fitzwater and Sen. Romine want to look at a sales fee on vehicles to fund transportation, based on the Oklahoma model.

Staff updated the committee on phase four of the sidewalk survey.

Environmental and Meramec Regional Emergency Planning Committee

Staff passed out a report on environmental and MREPC activities. Report is attached.

Marla Stevenson reported that MRDC met on June 17. A report was handed out and is attached.

- Staff met with Show Me Benefits to discuss health insurance for staff. The plan is partially self-funded and includes a wellness program. Staff is still reviewing. If board members are interested in learning more, contact staff.
