### **Special Presentation of Eugene E. Northern Award:**

MRPC's Eugene E. Northern 2013 Award recipient was unable to attend the Annual Dinner in Potosi, so Chairman Brown presented the award to recipient Richard Huse of Belle at this meeting.

### **Idea Exchange with Federal Legislators Staff**

Mr. Dan Engemann, for Rep. Blaine Luetkemeyer; Ms. Sarah Graff for Sen. Roy Blunt; Mr. Cole Karr for Rep. Vickie Hartzler and Mr. Matt Williams for Sen. Claire McCaskill attended MRPC's board meeting.

Each representative for the legislators updated the board on legislative activity.

The following is what they conveyed to the board:

Ms. Graff informed the board that Congress has passed a \$1.1 trillion budget. The Fair Market Act has been passed out of the Senate and is in House Judiciary Committee. Farm Bill in conference committee and is expected to be passed out by end of January.

Mr. Matt Williams informed the board that Sen. McCaskill's office is collecting testimonials from homeowners experiencing flood insurance issues. He said insurance rates are going up and FEMA is putting properties in flood zones that were not there before.

Mr. Engemann explained that the appropriation bill that passed the house has included reductions in spending—eliminates the Missouri River Restoration Project (MRERP); reduced budgets for the IRS and EPA. Rep. Luetkemeyer feels that the process is moving in the right direction.

Mr. Cole Karr informed that he was new to Rep. Hartzler's office; he discussed the Farm Bill and concerns with Ft. Leonard Wood. Mr. Karr said that defense spending was increased by about \$30 billion in the 2014 budget, and it is Rep. Hartzler's wish to direct some of that increase to readiness, which could benefit Fort Leonard Wood.

The group fielded questions from board members, including questions on BRO funding and coal fire power generation.

### **External Relations Committee**

Leo Sanders reported on External Relations Committee activities as follows:

- **MRPC Day at the Capitol**

The committee discussed a date for "MRPC Day at the Capitol" which is set for Jan.28. MRPC will provide lunch from 11:00 a.m.-1:00 p.m. in the hallway in front of Senator Dan Brown's office, Room 419.

- **Federal Priorities for 2014**

Committee reviewed the federal priorities survey results. There were 11 responses on the survey. MRPC leadership will hand carry the reports to Washington, D.C. in March. The committee decided to table the priorities until Feb. 13 meeting and do some final word-smithing.

- **MRB Bylaws Review**

The committee reviewed the MRB bylaws. No changes are recommended.

### **Operations Committee**

Ray Schwartze reported on Operations Committee activities as follows:

- **Financials**

Committee reviewed December financials and discussed in detail the 2013-14 budget revisions. John Casey made a motion to approve the MRPC financial statements and MRPC/MRDC-RLF & IRP program financial statements for the period ended December 31, 2013 and the revised budgets; seconded by Mark Boyer. The motion carried.

John Casey reviewed the prioritized transportation needs list for the Meramec Region that was prioritized at the Dec. 12 TAC meeting.

Ray Schwartze made a motion to approve the ranking as presented; seconded by Don Brackhahn. The motion carried.
