Ms. Ivry Karamitros and Mr. Yan Li, Missouri Department of Economic Development—International Trade Office

The Missouri Department of Economic Development has an International Trade office that promotes Missouri products and services globally, increases the number of Missouri businesses exporting and helps facilitate international business opportunities.

•••••

The State of Missouri recently opened new Trade and Investment offices in Canada, Germany, Hong Kong and Singapore last November. Overseas offices assist Missouri companies in getting their products and services to overseas export markets.

Services available through these Trade and Investment offices are trade counseling, agent/distributor search, business protocol, customized market research, export finance programs, export due diligence, foreign trade missions, customized company missions, international trade shows, trade leads, Missouri export directory and certificates for free sale.

Through a new program known as Global Market Access Program (G-MAP), the state offers a cost-sharing program that helps Missouri small businesses participate in international trade shows, trade missions and events to get their products in front of a global audience. General marketing activities that qualify for 2015 funding are: trade show exhibition, foreign trade mission, foreign market sales trip, subscription services provided by the USDOC, USDA, DED or MDA, language translation fee and market media.

To be eligible for the programs, a Missouri Company must have been have to be in business for at least three years, have 500 employees are less, \$25 million or less in annual sales, exported to at least one market (Canada counts), 51 percent of the value of the product derived in Missouri and have a strategic plan for exporting.

Board Discussion on EPA Regulations on the Clean Air Act as related to Carbon emissions: Bonnie Prigge

Don Shaw presented on EPA regulations at our August meeting. EPA is accepting comments until Oct. 16. Board discussed if it would wish to send a letter of comment.

Darrell Skiles made a motion to send a letter of comment to EPA; James Poucher seconded the motion. The motion passed.

Board and Committee Reports

External Relations Committee: Darrell Skiles, chairman

The External Relations Committee met at 6 p.m. Committee reviewed and discussed Eugene E. Northern Award and volunteer nominations; Veteran's Program; Silent Auction; Reception; Budget and Menu selection. Award winners and menu was selected. Time of the meeting will be 5:30, reception at 6:00 and dinner following at 6:30. The ticket cost will increase to \$30. Committee reviewed the list of state legislative priorities briefly and will review at the October meeting.

Operations Committee: Marvin Wright, chairman

After committee review and approval, Marvin Wright made a motion to approve the MRPC financial statements and MRPC/MRDC-RLF & IRP program financial statements for the period ended August 31, 2014; seconded by Dennis Wilson. The motion carried.

Staff presented BuyBoard, an online purchasing program. This online purchasing cooperative designed to streamline the purchasing process for eligible governmental entities and is a bid process that meets MRPC procurement standards. The committee would like more information on the new program.

Planning Committee: James Morgan, chairman

Committee discussed and commented on the draft state legislative priorities list for 2015 and made a few recommendations.

Committee members continued discussion of workshops to be considered for current and future programs and services as discussed at the Board Strategic Advance.

Housing Advisory Board: Darrell Skiles, chairman

Staff presented a statement of revenues and expenditures for the month ending August 31, 2014. Year-end financials for 2013-2014 were also presented.

Staff briefed the board on the number of families assisted and the amount of housing assistance payments for each of the six counties.

Environmental: Tammy Snodgrass, staff

Staff passed out a report on environmental and MREPC activities. Report is attached.

Business Loans: Marla Stevenson, at-large representative for banking

Staff is working on a loan in Pulaski County for \$293,000. There is \$844,111 in the RLF fund to lend. Staff is currently working on reaching out to communities about programs available. A report was handed out and is attached.

Workforce Development: T.R. Dudley

T.R. Dudley reported on attending the Delta Regional Authority on workforce development meeting in Poplar Bluff and, due to time constraints, will update the board in more detail next month.

Meramec Community Enhancement Corporation (MCEC): John Petersen

Staff is currently working on the MHTF grant used to rehab houses in the region, in the amount of \$58,000.

MCEC has a contract on the house in Cuba.

There is still a need for contractors for the rehab projects.

Meramec Regional Community Foundation (MRCF): Bonnie Prigge, Executive Director Bonnie Prigge reported that staff attended a meeting on Sept. 3, and discussed that MRCF and MRPC will be hosting an affiliate meeting at MRPC for other foundations to attend and CFO will be presenting.

There are three new members on the MRCF board, Gary Brown, Joe Scott and T.R. Dudley. Due to Marty Leathers resigning his post, a new member is needed to represent Crawford County.

Chairman and Director's Report

T. R. Dudley commented on the date being Sept 11, 13 years ago our country came together; would like to see differences put aside and everyone work together for the greater good.

Bonnie Prigge reported that Amy McMillen has left MRPC, and Lyle Thomas will be covering her duties.

MACOG is holding the annual meeting at the Lake on Oct. 1-2, and fiscal officers will be attending also.

Safe Routes to School has been changed to Alternative Transportation. The grant cycle deadline is Nov. 14 and the grant now requires a 20 percent match. Sidewalks and trails are examples of eligible projects.

LPA recertification training has been delayed and the state is relaxing the deadline. Online training is not yet available, and there will be a certification at the MAC conference in February. Training will be available in October.
