Linda Loughridge presented the audit that was completed for June 30, 2015. The auditor's opinion, the financial statements referred were presented fairly, in all material respects, the respective financial position of the governmental activities of the Ozark Rivers Solid Waste Management District as of July 1, 2014 thru June 30, 2015, and the respective changes in financial position, for the year then ended in conformity with generally accepted accounting principles. Ms. Loughridge stated that the audit was a clean audit. No deficiencies were found. Randy Verkamp made a motion to approve the audit as presented. Ray Schwartze seconded the motion, which passed unanimously.
