RHSOC OLD BUSINESS

Staff provided the project status report handout for review (attached). Round 1 FY14 spending must be completed by August 31, 2016. With MRPC bidding out a trailer, most of the remaining balance will be expended. Round 2 FY14 spending must also be completed by August 31 and it is expected that those funds

will also be expended on time. Most of the funds in FY15 are with Rolla HRST and it is expected that these funds will be spent down by the August 31, 2017 deadline.

We are trying to recruit new members as we have several vacant positions. Ron Long informed the committee that this will be his last year as a member. Deborah Baker stated that she had brought Israel Doba with her who was interested in filling the alternate position for Health Department.

RHSOC NEW BUSINESS:

HSGP Peer Review:

HSOC members reviewed and scored the applications submitted via the WebGrants system. The total amount of the grant funds available is \$65,489.03. A table showing scores, initial rankings, adjusted rankings, requested funds and awarded funds is attached.

After group discussion of how the scores came out, the group decided that they wished to make interoperable communications the top priority. Furthermore they discussed how some of the grants might be reduced and still remain viable. A table showing the final grant awards as approved is attached.
