Missouri's Safety Circuit Rider Program**: Gidget Koestner, Field Liaison for LTAP, is working on developing the program direction and content in an effort to reduce fatalities on Missouri's roadways. Ms. Koestner will review the program which aims to assist LPAs in the analysis of safety issues and determining possible low-cost solutions for implementation.
