Direct Deposit of Housing Assistance Payments

Phelps County PHA utilizes direct deposit. This method of payment is beneficial to our landlords and reduces the cost of printing and mailing manual checks. Phelps County PHA guarantees that your check will be deposited on the second working day of each month.

To set up your direct deposit payment, you need to complete the enclosed form and attach to the form a VOIDED check or a bank printout to verify the account and routing number. Submit the completed form and voided check or bank printout to Phelps County PHA by fax or mail or drop it off at the PHA office, 4 Industrial Drive, in St. James.

If requested, a remittance slip confirming the details of the deposit will be sent by email or mail. It is our hope that most landlords and property owners will use their monthly bank statements as payment documentation. However, we recognize that those with multiple properties may need remittance slips.
