CHAPTER SIX: FUTURE MULTI-MODAL PROJECT PLAN FOR 10 YEARS

State System

The Statewide Transportation Improvement Program (STIP) is a five-year plan that is prepared annually by MoDOT. It includes all projects proposed for funding under the Moving Ahead for Progress in the 21st Century (MAP-21), Vision 100-The Century Aviation Act and state revenue. The STIP covers highways, bridges, transit, aviation, rail, waterways, enhancements and other projects. It is a project-specific document that tells citizens what improvements to expect on their transportation system during the period. Appendix A is the most current STIP for the Central District.

Multi-Modal Needs Identification and Prioritization

Beginning in 2013 Meramec Regional Planning Commission (MRPC) partnered with the Missouri Department of Transportation to develop a multi-modal needs list for the Central District.

MRPC coordinated the multi-modal needs identification and prioritization process for the region using existing staff, the Transportation Advisory Committee (TAC) and MRPC board members along with stakeholders representing various transportation modes from across the region. The process was inclusive, transparent and accountable, resulting in a prioritized needs list, by mode that reflects the desires of the Meramec Region and addresses all modes of transportation.

MRPC staff created a multi-modal contact list, made up of individuals and businesses that are either directly involved or impacted by transportation. The list includes transportation professionals, MRPC board members, TAC members, elected leaders, economic developers, and tourism leaders, educators, freight haulers, transportation providers, healthcare providers, emergency services, airport operators, residents involved in bike and pedestrian organizations as well as the general public.

At the April 10, 2014 meeting of the Meramec Region Transportation Advisory Committee, multi-modal needs were prioritized, with the following results:

In December 2019 and February 2020, the Transportation Advisory Committee (TAC) reprioritized seven existing and new alignment projects and reprioritized eight spot improvement projects along Hwy 63 in Maries and Osage Counties. While the four-laning of Hwy 63 through the entire Meramec Region remains the top priority for the TAC, the committee has now identified a stretch in Osage County from Freeburg to Vienna as being the most critical stretch to be addressed should funds become available. The TAC originally prioritized from one end of 63 and moved to the other through the region. During this prioritization, the committee took into count accidents, fatalities, safety concerns and possibilities of passing.

The last time the projects were prioritized by the TAC was 2009 and the projects were slated to cost approximately \$172 million. The prioritization of the new and existing alignment projects is:

- 1. A 9-mile stretch south of Osage County Road 524 to south of Maries County Road 332:
- 2. A 5.5-mile stretch south of Maries County Road 332 to south of Maries County Road 325;
- 3. A 7-mile stretch south of the bridge over Maries River at Westphalia to south of Osage County Road 524;
- 4. A 5-mile stretch from Hwy 50 to south of the bridge over Maries River at Westphalia;
- 5. An 8-mile stretch from south of Maries County Road 325 to just north of Hwy 68:
- 6. A 2-mile stretch from just North of Hwy 68 to south of Maries County Road 443; and
- 7. An 8-mile stretch from south of Maries County Road 443 to Phelps County Super 2.

With the understanding that current funding levels do not support large-scale re-alignment projects, the TAC was asked to prioritize eight smaller projects along Hwy 63's existing alignment that would improve safety and traffic flow in February 2020. These eight projects total approximately \$20 million.

The prioritization of the spot improvement projects is:

- 1. Build a northbound passing lane north of Freeburg starting at Route JJ and extending for 1.7 miles. This would include a southbound left turn lane at Route JJ in Osage County;
- 2. Build a southbound passing lane south of Freeburg starting approximately at city limits and extending for 2.2 miles in Osage County;
- 3. Build a northbound passing lane north of Vienna starting approximately 0.5 miles north of Route AA and extending 2.4 miles in Maries County;

- 4. Build a northbound passing lane starting at Route 28 near Vichy and extending for 3.3 miles in Maries County. This includes turn lanes at Route 28 on Hwy. 63;
- 5. Build a two-way left turn lane from County Road 511 to Mill Street in Westphalia;
- 6. Extend the southbound climbing lane south of Westphalia to Route T in Osage County;
- 7. Rebuild the Hwy. 63 and Route E intersection in Osage County; and
- 8. Extend the southbound climbing lane at Route A to go around the corner ending at the straightaway in Maries County.

This differs slightly from the prioritization the TAC completed of the spot improvement projects in December 2019. In late 2020 and early 2021, MRPC, MoDOT and the TAC completed a prioritization of the top two sections of each project (existing and new alignment) and a project on Highway 50 near State Technical College in order to provide MoDOT with the region's top high priority unfunded needs. In February 2021, the TAC voted to place the top two sections on the Highway 63 existing alignment as MRPC's top priority, with the two sections of Highway 63 on new alignment as the second priority, and the Highway 50 project at State Tech as the third priority. MRPC submitted the priorities to MoDOT following the February meeting for consideration in the Tier 1 and Tier 2 high priority unfunded needs lists. MoDOT has indicated that a third tier of projects will be discussed in the next fiscal year.
