## Business Spotlight — Quilting Bee Fabrics, LLC Hermann, MO







The Quilting Bee Fabrics is located in Hermann, Mo and provides a wide variety of cotton quilting fabrics, pre-cuts, quilt backings along with quilting patterns, threads, needles, zippers, rulers and all kinds of sewing accessories. Additionally, they offer quilting classes for beginners to superstar quilters.

Aimee Viehmann is the founder and owner of Quilting Bee Fabrics.

"I've always wanted to own my own retail business in Hermann," Viehmann said. "After thinking about it, I knew Hermann needed a quilt shop that showcases quality cotton fabrics and offers classes. I started quilting about 10 years ago. I find it a way to relax and be creative, and I wanted to share that with others including area youth."

The Quilting Bee Fabrics, LLC utilized MRPC's CARES Revolving Loan Fund (RLF) program to acquire working capital to start up the business. Viehmann has plans to increase employees at the Quilting Bee by two full-time employees and one part-time employee. The loan was approved in late 2020. The CARES RLF is a loan program designed to provide financing to small businesses that have been impacted by COVID-19 through the CARES Act. As these funds are repaid to MRPC, they will be available for relending.

## **Program Updates**

**COVID-19 EIDL Update**: As of January 1, 2022, SBA stopped accepting applications for new COVID-19 EIDL loans or advances. As of May 6, 2022, the COVID-19 EIDL funds were expended. SBA is no longer accepting COVID-19 EIDL loan increase requests or requests for reconsideration. The <u>COVID-19 EIDL portal</u> (covid19relief1.sba.gov, also known as the "RAPID portal") closed on May 16, 2022. Borrowers that need information on their EIDL Loan must call SBA's COVID EIDL Customer Service Center at 1-833-853-5638, 7-1-1 to access telecommunications relay services, or by email (include your loan number) at <u>DisasterCustomerService@sba.gov</u>. **SBA 7a Program Updates** – Beginning October 1, 2021 through September 30, 2022, loans approved are subject to the FY 22 program fees. For 7a loans approved for

\$350,000 or less, there will be fee relief of zero percentage (0%) on the upfront guaranty fee and annual fee. Loans must be approved by the end of the fiscal year, Sept. 30, 2022.

**MRPC's Revolving Loan Fund** – The RLF program has approximately \$400,000 available for relending to help small businesses located in Meramec's eight-county region. The counties include Crawford, Dent, Gasconade, Maries, Osage, Phelps, Pulaski, and Washington. Funds borrowed through the program can be used for working capital, purchase machinery, equipment, furniture, fixtures, and inventory. The program can provide up to 40 percent of the funding or a maximum of \$100,000, funding 50 percent with a partnering bank (chosen by the borrower), and an owner's equity injection of 10 percent.
