**Approval of Minutes:** The board reviewed the minutes from December 14, 2021. Young made a motion to approve the minutes as presented, seconded by Vogt. Motion passed.

MRCF Community Grant Making Fund: The board reviewed and discussed the 22 applications requesting a total of \$10,905 and received for this year's community grant-making fund. There is \$1,500 available to award in grants this year (up to \$500 per award). After board discussion, Young made a motion to select the following 3 grant recipients for this year, seconded by Vogt; The Community Partnership, Christ Church Episcopal, and Council for Healthy Dent County. Each grantee will receive \$500. Bancroft mentioned that information on the luncheon will be sent soon and encouraged board members to bring a guest.

**Cavender Scholarship for Lucas Morrison:** Bancroft presented a request for approval to give permission for Lucas Morrison to use his remaining scholarship funds to a different school. The Cavender's are in support of his request. Vogt made a motion to approve the request, seconded by Harris. Motion passed.

It will cost approximately \$69 million to build a larger part of the trail (from Buford to Eugene) which includes some of MRPC's region counties.
