Rosebud. Each of these communities is located along the Rock Island Trail and the plans address active transportation connections to the trail.

- 7. DHSS Active Transportation Plan Grant: MRPC recently received approval of another Active Transportation grant opportunity with the Department of Health and Senior Services. Staff will review statistics and information gathered to identify the next city to work with over the next few months.
