- **3. TAP Application Ranking:** TAC members will be asked to rank the projects in priority order. MRPC and local jurisdictions will present a brief overview of each project and then committee members will rank each project. The final ranking will be presented to the MRPC board for review and approval and then submitted to the Central District MoDOT. Selection of Nominating Committee: According to the TAC Bylaws the chairman of the committee is to appoint a nominating committee of not less than four members, to present names for consideration as officers at the August meeting. No individual currently holding the position of officer may be a member of the nominating committee. During the course of the annual election, nominations may also be made from the general membership. Officers will be elected for one-year terms and will serve until their successors are qualified. No officer may hold the same office for more than two consecutive terms." Committee action required.
