MCEC Grant Updates: Kelly Sink updated the board on recent applications submitted.

- Community Foundation of the Ozarks A grant of \$23,400 was submitted for the Youth Mental Health Program. It was not awarded.
- MO Department of Economic Development A grant was submitted for the Digital Opportunity Grant program for \$258,000 for a 2-year program to provided electronic devices for public access to the internet as well as training for potential users. It was not funded.

Approval of financials: Bethany Ferrell presented financials through the period ending February 28, 2025. The report included revenues and expenditures and balance sheet.

She noted that the Vichy Renewable Energy grant had been added for \$2500. Darryl Griffin made a motion to approve with second by Gary Hicks. *Motion was approved*.

Approval of FY24-25 Revised Budget: Bethany Ferrell presented the FY24-25 revised budget audit. Changes noted included adding to the DRA Naturally Meramec line item which is now closed, adding the Vichy Renewable Energy grant and decreasing the software expanse line item. Vic Stratman made a motion to approve the audit with second by Darryl Griffin. *Motion was approved*.
